This year, as RMHC globally celebrates 50 years of unwavering commitment to families, and as we edge closer to our 40th anniversary here in Southwestern Ontario, we reflect on the incredible journey we've embarked upon. A journey made possible by the dedication, generosity, and compassion of many individuals like you.

Our mission to support families with ill or injured children has never been more vital. It's a mission that calls us to be more than just a charity; it calls us to be a beacon of hope in our community's darkest times. In 2023, we had the

privilege of serving 3,238 unique families across all our core programs, and they stayed with us for an average of 18 days—a significant period during which we became their home away from home, their sanctuary of comfort and support. It is important to remember that this number is not just a statistic; it represents individual stories of hope, resilience, and community.

All of this would not have been possible without our over 1,000 volunteers and countless donors, whose dedication and compassion were instrumental in supporting families from 235 communities with 65,144 individual meals and home accommodations relieving emotional and financial stress weighing on caregivers, ensuring that our families were nourished in body and spirit.

Thank you for being part of this incredible journey. Here's to many more years of making an impact together.

- 10 years ago, the operational cost per family per night was \$100. Now, the costs associated with their stay exceed \$500 per day, per family.
- In 2013, the average length of stay, in the House, was 7 days. 10 years later, the average length of stay is 16 days.
- In 2013, the organization ran at capacity for just 134 nights each year. Now, we have operated at more than 110% capacity since 2019.



- In 2015, families spent 1,000 nights on the waitlist vs. 2,500 nights in 2020. This number continues to grow, which means, countless families are unable to access a safe, comforting and convenient place to stay when their children are coping with profound health challenges.
- Last year, RMHC-SWO saved families \$4.7 million dollars. Equally as important, we gave ill and injured kids exactly what they needed: caregivers who are close enough to hug, kiss and play with.

OUR COVER STORY

A LETTER FROM THE CRITCH FAMILY

My name is Katherine and I just wanted to say thank you for keeping my family close to our 6-month-old son, Dominic, for 5 and 1/2 months while he received cancer treatment in London, ON. The friendships we made will last forever and the amount of love we felt will be cherished for as long as we live.

Hours away from our community in Owen Sound, there were many things made this place feel like our "home-away-from-home"...

The homemade meals made with love by volunteer groups that so graciously gave their time to feed our souls.

The multipurpose space where I could watch my kids play, spending endless hours having dance parties and making crafts.

The feeling of family. Other families dealing with difficult diagnoses came together to talk, share, cry, celebrate good news, and just be there for one another. It helped to know you weren't alone.

Most of all, our room will forever be engrained in my heart. The room where we rested after long days at the hospital. The room where we talked about the worst news we received and rejoiced when we got the best news. It was where we could all be together as a family, and that was the best thing you could give us.

We were able to watch our son experience so many firsts we may have otherwise missed...

First MRI, CAT scan, surgery, blood transfusion, chemotherapy and so much more. But we also got to experience his first time crawling, first tooth, eating solid foods, first words, first time standing while holding onto things, and first time climbing stairs. Those moments brought us light in a dark time.

Our 3-year-old daughter, Blake, knew her brother was very sick and we needed to focus on him, but at the House she still got the attention and care she deserved. She became so well known to everyone and looked forward to seeing all the staff, volunteers, and families. She also began to understand that some of those children would leave to go home, and not to be sad because that was a good thing. And eventually, we hoped, that day would come for us as well.

Well, that day finally came, and as we left the House we took the memories with us, the good and the bad. The road to recovery will never end but we want to thank you for helping us on this journey. It's not goodbye, just see you later.

We want to thank all the RMHC Southwestern Ontario volunteers, donors, and staff from the bottom of our hearts!

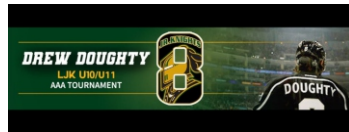

Treasurer's Report

Year Ended December 31, 2023

Financial Position as at December 31, 2023

Operating bank accounts were higher than normal level with a balance of \$436,425 (2022 - \$291,602) at the end of the year, representing approximately 4 months of operating expenses.

Investments were \$8,805,280, an increase of 11.9% from 2022.

General Fund

There was an increase in the General Fund in 2023 of \$1,062,961. This increase was due to \$3,858,877 in revenues, \$3,550,168 in expenses, \$834,273 in investment income and (\$80,021) of interfund transfers related to Capital Asset purchases.

Capital Asset Fund

There was a decrease in the Capital Asset Fund in 2023 of \$325,720. This was due to capital asset additions of \$174,765 and amortization of capital assets of \$500,485. A detailed breakdown of Capital Assets can be found in the Audited Financial Statements.

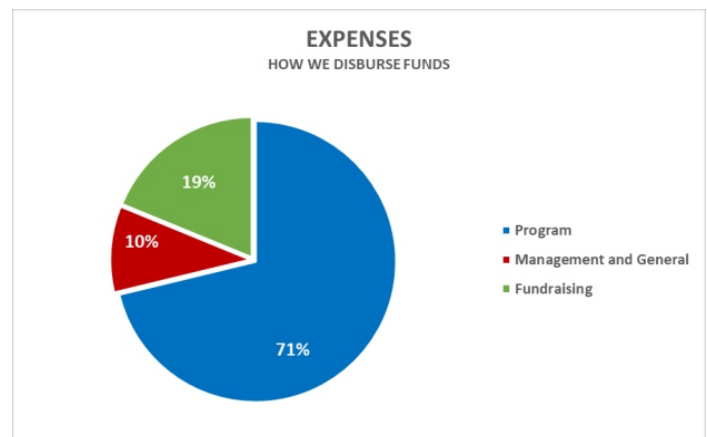
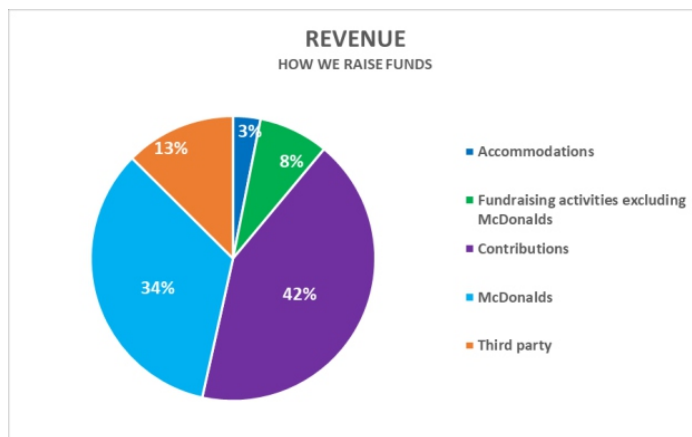
Restricted Fund

There was an increase in the Restricted Fund in 2023 of \$266,499. This increase was due to \$608,930 in restricted revenues, \$247,687 in restricted expenses and (\$94,744) of interfund transfers related to Capital Asset purchases.
